Hey Bob, how is it going? How are you doing? When I heard that they "turned you out" in Washington, no car..nothing, I felt bad for you. I had the same thing done to me in Minneapolis. Awful. Anyhow, you sound as good as one can via email. The main nut to my case was whistleblowing, but they papered me so badly that the attorney (Stephen Kohn) did something that he normally does not do....that is split cases.

Stephen took over my case from a schlock attorney in Washington. That guy had filed an EEO, but it was always a whistleblowing matter. Stephen did the Privacy right case, the EEO, the Whistleblower case, and a fourth matter which I cannot even remember at this point.

Turned out that was a good move, even though he hated to do it, because the Bureau was relentless in piling false information upon false information. I was deluged with paper that they cajoled, pressured, and just invented. It has been seven years, a huge amount of financial and mental pressure, but I have finally prevailed in one matter. The whistleblowing action is still going on, in Washington D.C. (not the Office of Special Counsel). My case, and Dot Werhly out of Colorado is in the Office of Recruitment and Personnel at DOJ. Weird arena for hearing these matters, but I guess these particular FBI cases were diverted from the OSC to the ORP. Go figure. Stephen Kohn has most of the info. He will be at the NSWC meeting in October, and you and John Vincent will have a chance to talk to him then. I am sure he would be delighted to share time with you.

Bob, I know it is hard dealing with the Bureau when they kick you out of the family tent, but please feel free to use my case, my time or anything else you would like in order to be successful in your fight. I would be glad to come and testify in your behalf on retaliation against FBI Agents when they blow the whistle. I can even testify that personnel matters that my managers filed were false. The Circuit Court even determined that.....your attorney, Mr. Vincent is going to assist me on the FFD charades. I certainly want to assist you in any way I can.
