[REDACTED] Jefferson City, Missouri, [REDACTED] telephonically furnished the following information regarding a telephone call she received this date from [REDACTED]

[REDACTED] is employed by the [REDACTED] Jefferson City, telephone number 314-[REDACTED]

[REDACTED] advised that she, and her friend [REDACTED], witnessed the incident involving WILLIAM JONES at the JUNGLE BAR in May, 1993. They were previously interviewed by a police officer and an FBI agent regarding what they observed.

[REDACTED] further advised that on this date, she received a telephone call at work from a woman who identified herself as [REDACTED] the mother of WILLIAM JONES. [REDACTED] wanted to know what she saw the day of the shooting at the JUNGLE BAR. [REDACTED] stated that she explained to [REDACTED] what she saw, and [REDACTED] kept trying to "twist her words." [REDACTED] also wanted to know what the FBI agent looked like. She wanted to know his height, age, weight, what he was wearing, color of his hair, and everything about him. [REDACTED] stated that she told [REDACTED] that she believed he was wearing a blue shirt and tan pants. [REDACTED] kept asking about his description, and [REDACTED] refused to answer her questions, and the call was ended.

[REDACTED] stated that [REDACTED] scared her by the way she acted on the phone, so she told her fellow employees that if [REDACTED] called back, they were to tell her that [REDACTED] no longer worked there.

[REDACTED] stated that she felt she should call because [REDACTED] wanted to know what the FBI agent looked like.
